## ESTATE AND PLANNED GIVING

Including Arizona Helping Hands in your final giving plans allows you to enjoy the benefits of a gift to charity, while leaving a lasting legacy.

There are many ways to benefit AHH as you make final giving plans:

- Name Arizona Helping Hands as a beneficiary in a Will or Living Trust.
- Make a gift of cash or appreciated securities to establish a charitable gift annuity with Arizona Helping Hands.
- Name Arizona Helping Hands as the beneficiary of a paid life insurance policy or a retirement account.

**To include Arizona Helping Hands in your plans, you will need the following information:**

### TYPES OF BEQUESTS

**Specific Bequest.** A specific bequest involves making a gift of a specific asset such as real estate, a car, other property or a gift for a specific dollar amount. For example, you may wish to leave your home or \$15,000 to Arizona Helping Hands.

**Percentage Bequest.** Another kind of specific bequest involves leaving a specific percentage of your overall estate to charity. For example, you may wish to leave 15% of your estate to Arizona Helping Hands.

**Residual Bequest.** A residual bequest is made from the balance of an estate after the will or trust has given away each of the specific bequests. A common residual bequest involves leaving a percentage of the residue of the estate to charity. For example, you may wish to leave 25% of the residue of your estate to Arizona Helping Hands.

**Contingent Bequest.** A contingent bequest is made to charity only if the purpose of the primary bequest cannot be met. For example, you could leave specific property, such as a vacation home, to a relative, but the bequest language could provide that if the relative is not alive at the time of your death, the vacation home will go to Arizona Helping Hands.

### BEQUEST BENEFITS

A bequest is generally a revocable gift, which means it can be changed or modified at any time. You can choose to designate that a bequest be used for a general or specific purpose so you have the peace of mind knowing that your gift will be used as intended. Bequests are exempt from federal estate taxes. If you have a taxable estate, the estate tax charitable deduction may offset or eliminate estate taxes, resulting in a larger inheritance for your heirs.

### BEQUEST LANGUAGE

In order to make a bequest, you should speak with your attorney. Your attorney can help you include a bequest to Arizona Helping Hands in your estate plan. We have provided some basic bequest language to assist you and your attorney.

### SAMPLE/SUGGESTED BEQUEST LANGUAGE

#### 1. SPECIFIC BEQUEST

If you are considering making an outright bequest to Arizona Helping Hands, we recommend the following language:

#### BEQUEST OF A SPECIFIC DOLLAR AMOUNT

I hereby give, devise and bequeath \_\_\_\_\_ and No/100 dollars (\$DOLLARS) to Arizona Helping Hands, a nonprofit organization located at 3110 E. Thunderbird Road, Suite 100, Phoenix, AZ 85032, Federal Tax ID #86-0935988, for Arizona Helping Hands general use and purpose.

#### Bequest of Specific Personal Property

I hereby give, devise and bequeath DESCRIPTION OF PROPERTY to Arizona Helping Hands, a nonprofit organization located at 3110 E. Thunderbird Road, Suite 100, Phoenix, AZ 85032, Federal Tax ID #86-0935988, for Arizona Helping Hands general use and purpose.

#### BEQUEST OF SPECIFIC REAL ESTATE

I hereby give, devise and bequeath all of the right, title and interest in and to the real estate located at ADDRESS OR DESCRIPTION OF PROPERTY to Arizona Helping Hands, a nonprofit organization located at 3110 E. Thunderbird Road, Suite 100, Phoenix, AZ 85032, Federal Tax ID #86-0935988, for Arizona Helping Hands general use and purpose.

#### **2. PERCENTAGE BEQUEST**

If you are considering making a bequest of a percentage of your estate to Arizona Helping Hands, we recommend the following language:

I hereby give, devise and bequeath \_\_\_\_ percent (\_\_\_ %) of my total estate, determined as of the date of my death, to Arizona Helping Hands, a nonprofit organization located at 3110 E. Thunderbird Road, Suite 100, Phoenix, AZ 85032, Federal Tax ID #86-0935988, for Arizona Helping Hands general use and purpose.

#### **3. RESIDUAL BEQUEST**

I hereby give, devise and bequeath to Arizona Helping Hands, a nonprofit organization located at 3110 E. Thunderbird Road, Suite 100, Phoenix AZ, 85032 Federal Tax ID #86-0935988, ALL OR A PERCENTAGE of the rest, residue and remainder of my estate to be used for Arizona Helping Hands general use and purpose.

#### **4. CONTINGENT REQUEST**

If (primary beneficiary) does not survive me, then I hereby give, devise and bequeath to Arizona Helping Hands, a nonprofit organization located at 3110 E. Thunderbird Road, Suite 100, Phoenix AZ, 85032 Federal Tax ID #86-0935988, ALL OR A PERCENTAGE of the rest, residue and remainder of my estate to be used for Arizona Helping Hands general use and purpose.
